The Department of Interior Design is pleased to offer the following scholarship opportunities for our students.

To be eligible students need to meet the following criteria:

- IND major in good standing
- Upper division or graduate student
- Be enrolled for a min. of 12 credits the semester the award becomes effective
- Documented financial need (FAFSA or attached Financial Needs Test)
- 3.2 minimum gpa

Cirino-Shore Family Endowment Scholarship

For students who show academic excellence and financial need.Amount: up to \$1,000Application Due: September 15

Robert E. Smith Scholarship

For 3rd and 4th year students who, in addition to academic excellence, demonstrate leadership qualities, and professional and/or community engagement.

Amount: up to \$500 Application Due: September 15

Field Trip Travel Scholarship

To support travel for field trips held during the Junior and Senior years for students with financial need.

Amount: up to \$300 Application Due for Fall Field Trip: October 3 Application Due for Spring Field Trip: February 15

Summer Travel Scholarship

To support travel to the summer abroad program in Germany or an approved similar program for students with financial need.

Amount: up to \$500 Application Due: March 15

Chair 4+1 MID Scholarship

To support students pursuing the 4+1 Combination Degree Amount: up to \$1,250 Application Due: April 15

Chair Dissertator Scholarship

To support unfunded Ph.D. students with dissertator status Amount: up to \$1,500 Application Due: October 3

FINANCIAL NEED TEST FOR SCHOLARSHIP CONSIDERATION

Undergraduate students must apply for federal financial aid on the Free Application for Federal Student Aid (FAFSA) to determine if they meet the financial need criteria as established by the University of Florida for a need-based scholarship. Graduate students are not required to use the FAFSA to determine financial need, but a needs test of some sort must be used by the department if the FAFSA is not used. All international students (whether undergraduate or graduate) must be evaluated by use of a needs test as they are ineligible to apply for aid on the FAFSA.
