- 2012 **Re-visioning Sacred Space: An Open Space Sacred Place for the Cotton Club Museum & Cultural Center. Gainesville, Florida**  
Principal Investigator on a \$1,000,000 proposal with an interdisciplinary team of practitioners, academics and East Gainesville Cotton Club community stakeholder's for the National Open Space Scared Places Award Initiative. Proposal was not selected.

An interdisciplinary team of faculty from the University of Florida provided assistance to Hamilton County with economic and physical planning. Ranking second to last in per capita income among all Florida counties, this project aims to facilitate the citizens of the county to raise their standard of living, achieve higher educational levels and improve their quality of life. This three year \$365,000 grant was organized by the School of Natural Resources and Environment with the collaboration of the Departments of Family, Youth and Community Sciences, Food and Resource Economics, Urban and Regional Planning, Landscape Architecture and the University of Florida Institute of Food and Agricultural Sciences (IFAS) County Extension Office.

 The Waldo Road Corridor Visioning study is an interdisciplinary effort between University of Florida faculty and students in architecture, urban and regional planning and landscape architecture in collaboration with municipal agencies and local stakeholders to coordinate conceptual planning policy, ecology, transportation and land use strategies that enhance livability and provide economic opportunity for East Gainesville. The University of Florida, the City of Gainesville and Alachua County will partner in this effort through a \$105,000 grant to extend the value of existing infrastructure and leverage new investment towards a unified community vision.
- 2004 **Design Competition for the Greenspace Master Plan for Ross Bridge Development.**  
*Birmingham, Alabama*  
 This national design competition addressed issues of park design focused on historic preservation of a Confederacy bridge; ecological remediation for a disturbed creek; historical & ecological interpretation; design guidelines for minimizing the negative impacts of stormwater from development on water quality & quantity on natural waterways; and greenspace connectivity & trail system design. One student in the studio won second place out of forty entries.
- 2003 – 2004 **Costanera Sur: Gateway to the Osa. A Scenic Development and Conservation Corridor.**  
*Southern Pacific Coast, Costa Rica*  
 Working in collaboration with an interdisciplinary and interinstitutional team of Costa Rican students and professionals in landscape architecture, architecture and environmental law from the University of Florida, University of Costa Rica and the Universidad de Diseño, the team developed a proposal for a scenic development and conservation corridor, the first in the country, along the Costanera Sur highway in the economically depressed but ecologically rich southern Pacific Coast of Costa Rica. The proposal addresses multiple issues: a more sustainable pattern of integrated conservation and tourism/community development; safety mitigation for pedestrians and wildlife from the impacts of the relocated inter-American highway along this corridor; the design of a multi-modal canopy road incorporating bicycle lanes, sidewalks and horse trails for use by locals and tourists; and the protection and enhancement of public access to beaches within the coastal zone.
- 2003 **TROPARC: Center for Environmental Planning and Design in the Americas.** *University of Florida, Department of Landscape Architecture*  
 Became the center's new director with a mission to advance environmental planning and design in the Neotropical region of the Americas through interdisciplinary project development, research and education.
- 2002 **Created Stormwater Wetland Design: Sweetwater Branch in the Duckpond Neighborhood & the University of Florida's Cultural Complex.** *Gainesville, Florida*  
 In an effort to reduce the negative impacts of stormwater on ecological systems, these projects focused on improved design and management of stormwater systems by using ecological engineering principles and created wetlands. In both projects, the designs: prevent flooding using pools and a floodplain/riparian system; use sinuosity in stream alignment to slow the speed of water; to reduce erosion, use rock covered walls at curved points and outfall locations and bio & photo biodegradable geotextiles on stream banks for plant establishment; use native aquatic vegetation to help phytoremediate the water; and use a baffle system consisting of CDS (continuous deflective separation systems) boxes and diversion walls to help settle out sediment, remove floatable waste and capture free oils and grease in order to not overload the wetland capacity. The studio was conducted in collaboration with wetland ecologist Dr. Mark Clark.
- 2002 **Flagler County GIS Planning and Design Study.** *Flagler County, Florida*  
 Faculty and graduate students from the departments of Landscape Architecture and Urban and Regional Planning conducted a semester long Geographical Information System (GIS) study focusing on three areas of Flagler County. The first was to develop future land use plans for the year 2050 taking into account projected population growth for the county. Flagler County is the fastest growing county in the state of Florida. The second was to study the impact of this growth on the coastal area. And the third was to develop redevelopment plans for the city of Flagler Beach addressing the stormwater and flooding problems and developing an urban design vision for the city for the year 2050. The studio was conducted in collaboration with the Florida Community Design Center.

In order to facilitate the planning process undertaken by the city of Gainesville and Alachua County, an environmental design studio was conducted in collaboration with Professor Tom Hctor to develop Master Plans for East Gainesville. These Master Plans addressed conservation lands as an integral part of the areas identity, integration of transportation and land uses, strategies for infill and protection of existing neighborhoods. The studio also developed graphic boards to help residents better understand current planning concepts to facilitate their participation in the planning process. And, in order to plan within a contextual framework for East Gainesville, the studio began by using GIS to determine suitability of land in Alachua County for conservation, agriculture and urban development. The studio was conducted in collaboration with the Florida Community Design Center & was presented to public officials & area residents.

Landscape Architect and Land Planning member of an international interdisciplinary team organized by the Wildlife Conservation Society to develop a Comprehensive Management Plan for the World Heritage site of the Maya Ruins of Copan Archeological Park in Copan, Honduras. The study includes the development of an emergency plan to address damages incurred from Hurricane Mitch in 1998; the development of a master plan addressing changes needed to better accommodate visitors while offering improved protection of the cultural and natural resources of the park; development of a plan to improve the connection and mitigate the impact from visitors to the adjacent city of Ruinas de Copan; develop a regional plan that addresses expanded tourism potential to other archeological sites as well as sites with ecotourism potential for improved economic benefit to the local communities. This project was undertaken by a team of U.S. and Honduran collaborators funded by a \$1,000,000 loan from the World Bank to the government of Honduras.
