## Course Description

Safety and health issues as they pertain to construction workers on international projects will be discussed in this class. Emphasis will be given to practices, conditions, and substances that are most problematic in the construction industry. The class will review safety best practices that have proven to be viable means of reducing construction worker injuries. Particular focus will be on recent innovative techniques that have proven to be effective in reducing worker injuries on construction sites. Resources related to safety and health will be explored.

## Student Learning Outcomes

Upon completion of the course students will demonstrate their ability to:

- Understand factors that affect safety on international construction project
- Critically analyze current research on project safety management
- Assess cultural impacts on project safety
- Apply methods learned in class to improve project safety and loss control

### **In-Class Recording**

To “publish” means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a

recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
