COURSE DESCRIPTION

This is a required course that requires up to three credit hours before graduation for all IND graduate students. This course is offered for each semester and provides an overview of our Master of Interior Design (MID) and PhD programs to both MID and PhD students for their effective graduate studies at UF. The primary goal of the course is to help students take responsibility for their successful graduate studies as well as build a sense of community. This course is designed in a seminar/conference format.

COURSE OBJECTIVES

This course is intended to help students:

- Be better equipped to make the most of their graduate study experience.
- Map out their goals for their graduate studies and contextualize their academic concentration.
- Initiate to develop their research/design projects and seek out their faculty mentors.
- Create a positive community culture by working together toward a shared goal for their graduate studies and leveraging their peer network.

REQUIRED TEXTS

No textbook is required for this course.

MATERIALS AND SUPPLIES FEES

COURSE FORMAT

Class format will combine lectures, assigned readings, discussions, presentations, peer critics, web browsing/searching/reading, and writing. The goal of this class is to create an environment for students to discuss their opinions about their graduate studies in class.

PARTICIPATION

The seminar format requires that you are actively participate in class. Your active participation and presentation are critical to its effectiveness because the class is truly student driven. Student participation is a main component of this course. As such, class participation is an integral part of your learning experience. Participation of all discussions is necessary for the successful completion of this course, and you will be expected to stay for the entire class period.

ATTENDANCE

Attendance in every class period is expected. Understanding that sickness or other unfortunate circumstances outside of your control may occur, you will be allowed to miss no more than two classes without questions. However, your assignments are still due on the originally scheduled due date, unless you make other arrangements with the instructor PRIOR to the due date. Each missed class after that will result in a 2% reduction of your final grade, unless the absence is excused and the reason for the absence verified (e.g., doctor's note). If you know in advance of a class that you will be missing it, please inform the instructor. Each student is expected to be on time for class to avoid distractions for the instructor and the other students.
