COURSE DESCRIPTION

Cultural Resource Management (CRM) studies the process of balancing contemporary needs with conserving heritage resources in the built environment. CRM encompasses many disciplines, architectural history, historic preservation of the built environment, historical research, and archaeology. This course builds professional skills in applying the principles and tools of CRM to case study projects.

The North Riverside area of Jacksonville was settled by former African American soldiers and freed Gullah Geechee after the Civil War. The area became the industrial center of the city in the early-20th century, bungalow and shotgun neighborhoods provided close living quarters for African American workers in the manufacturing sector. During the 1950s-1970s, the construction of Interstates 10 and 95 isolated the N. Riverside area from its historic “sister” neighborhoods.

Building on the prior research from the Cultural Resource Survey course, participants will develop a draft nomination for the neighborhoods of Mixontown and Lackawanna to the National Register of Historic Places. The final deliverables will include a draft of a nomination form and accompanying documents, a public presentation on the research findings, and recommendations for leveraging this rich heritage for ongoing community revitalization work.

COURSE OBJECTIVES

- Understand the process for identifying, documenting, and evaluating resources for inclusion in the National Register of Historic Places.
- Work with community stakeholders to research the history and the significance of the community.
- Gain experience in preparing a nomination for the National Register of Historic Places.
