### CLASS LOCATION AND MEETING TIMES

The IPAL 5 seminar meets eight times during the semester for two-hour seminars. The class is primarily online.

**ARC6911 – IPAL 5 is an online course; there are no in-person meetings.**

### COURSE DESCRIPTION

IPAL 5 is the final seminar in the IPAL sequence you are required to take. This one-credit seminar focuses on understanding ethics for architects. There are reading assignments for every seminar class that we will discuss during the class meeting. I expect every student to participate in class discussions and complete the required reading before the class meeting.

### REQUIRED TEXTS AND SOFTWARE

There are no required textbooks for this course, and any required reading will be provided on canvas.

All students must purchase a Microsoft Word add-in **Grammarly Premium**, [www.grammarly.com](https://www.grammarly.com), "a cross-platform cloud-based writing assistant that reviews spelling, grammar, punctuation, clarity, engagement, and delivery mistakes." Download the Microsoft Office add-in, then upgrade to Grammarly Premium.

**A Grammarly Premium review is required before the submission of any writing assignment.**

### ATTENDANCE AND PARTICIPATION

Class attendance is mandatory, and absences count from the first class onward. Students are expected to arrive on time and remain in for the class duration. Unexcused absences and leaving class may result in a reduction of the final course grade. Our policy on attendance is stringent: You must explain any absence. Contact your professor via email.
